Foster Contract for Orphan Foal

Policy Outlines and Rules for Adoption of Hoofs2010Inc" Brumby Foal

1. All foals must be kept in healthy condition and receive any specialist treatment when necessary.
2. All basic care must be attended to, and all health programmes maintained in a manner to sustain the foal's wellbeing.
3. The rescued foal may never be sold or transferred and in any case must be returned to the Association if no longer to be in care of Foster Carer
4. Hoofs2010 Inc will offer consultation and assistance if the Foster carer has concerns with the rescued foal and will assist in a manner appropriate to the needs wherever possible of Brumby or Carer.
5. At all times the foal will be the main priority for both Hoofs2010 Inc and the Foster carer.
6. The Foster Applicant is to provide two written references on application for fostering from Specialists in the Equine industry.
7. The Association reserves the right to refuse any Foster Application
8. Hoofs2010 Inc will provide financial assistance for the foal's milk during the period of Foster care.
9. Foals fostered will require 4 hourly feeding, so the foster carer must be able to commit to providing feeding as required.
10. Foster carers must be able to provide evidence of suitable facilities to accommodate the foals needs, i.e safe contained yard, access to shade, water and hard feed and protection from in climate weather.
11. Foster Carers must live within a 3-hour radius of Berrigan NSW.
12. Foster Carers are asked to take on financial commitment for any injury that may occur whilst in their care, and notify Hoofs2010 Inc within 24 hrs, providing a detailed summary of injury, this includes a Vet report if necessary.
13. The foster Carers must agree to a Hoofs2010 Inc representative visiting foster care placement on mutual notification.
14. Hoofs 2010Inc require monthly written updates (see attached form)

This document is an agreement between Hoofs2010 Inc and the person named in the contract.

I have read and understand the contents of this document and initialled each page.
